Dear Secretary Noem,

According to public reporting, you altered a draft report produced by the Council to Assess the Federal Emergency Management Agency (FEMA), which was established at the direction of President Trump. The Council is set to release its findings on December 11, 2025. I urge you to release the Council's complete report.

The Council to Assess FEMA—which is comprised of governors, mayors, community leaders, and Republican party officials—was charged by President Trump with assessing potential reforms to FEMA.³ The Council submitted its 160-page draft report in November, reflecting nearly 13,000 public comments and a dozen meetings with communities across the country.⁴ The report contained reforms to improve FEMA's disaster response, including distributing assistance to states more quickly.⁵

Public reporting indicates that upon receiving the Council's report, you and your top adviser, Corey Lewandowski, whittled the recommendations down, eliminating roughly 140 pages of the Council's work.⁶ White House officials reportedly also received the draft report.⁷ Members of the

Council, appointed by President Trump,⁸ have raised concerns about your decision to alter the report.⁹

I categorically oppose any efforts to eliminate FEMA. I do energetically support reforms to streamline the disaster relief process. It is too burdensome for many small towns, particularly in rural areas.

Whether or not you agree with all of the Council's conclusions or recommendations, it is essential their complete findings be released without alteration or selective changes. This welcomes a robust discussion of the best reforms to improve FEMA. I urge you to release the Council's complete findings to the public immediately.
